



The undersigned is directed to convey the sanction order for the deputation of Mr. A.N.M. - (a) Total period of this program and the time spent for travel and transit will be treated as on duty;
  - (b) He will draw all parts of his pay and allowances in local currency;
  - (c) Only Taka 30,00,000.00 (Thirty Lac) was provided for Master Program from the "Strengthening Government through Capacity Development of the BCS Cadre Officials" project being implemented under the Ministry of Public Administration and sponsored by Japan Debt Cancellation Fund (JDCF);
  - (d) He will not be allowed to stay abroad more than the approved period;
  - (e) After completion of the course he will have to submit as well as present a report with Individual Action Plan (IAP), bill voucher to the Ministry of Public Administration.
  - (f) He is requested to sign a new bond in prescribed form before his departure.
  - (g) He is requested to submit the tuition fee acknowledgement receipt before departure from Bangladesh.

  3. This order is issued with the approval of the competent authority.


