- a. He will start his journey for Japan on a convenient date near to 05 March, 2018;
  - b. The approved period of this course and the time spent for travel and transit will be treated as on duty;
  - c. He will draw all parts of his pays and allowances in local currency and not in foreign currency;
  - d. All expenses related to this program will be borne by Japanese Grant Aid for Human Resources Development (JDS), Japan, and by himself.
  - e. He will not be allowed to stay abroad more than the approved period;
  - f. **His deputation period is from 01.03.2018 to 28.12.2020.**
  - g. **Duration of his Education Leave (on half average pay) is from 29.12.2020 to 31.03.2021.**
  - h. The provision of Appendix V and Rule 194 of BSR (Part-1) and provision of Rule 34 of BSR (Part-1) will be applicable in connection of this approval.
  - i. Before being considered for another overseas programme, he will have to serve the government for six years after returning from the programme
  - j. He will have to submit a report on the course to the Foreign Training Branch of the Ministry of Public Administration within five days after his return from the Course.
